

SUMMARY ANNUAL REPORT

MCPHERSON COLLEGE 403(b) DC PLAN

This is a summary of the annual report for MCPHERSON COLLEGE 403(b) DC PLAN, 48-0543736/001 for 01/01/2016 through 12/31/2016. The annual report has been filed with the Employee Benefits Security Administration, formerly known as the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

*Basic Financial Statement*

Benefits under the plan are provided by insurance and trust. Plan expenses were \$923,872. These expenses included \$31,579 in administrative expenses and \$892,293 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 383 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$15,086,719 as of 12/31/2016, compared to \$14,333,271 as of 01/01/2016. During the plan year the plan experienced an increase in its net assets of \$753,448. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,677,320, including employer contributions of \$593,656, employee contributions of \$92,766, gains of \$0 from the sale of assets and earnings from investments of \$990,898.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes, if any, will be included as part of that report. The charge to cover copying costs given above does not include a charge for copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 1600 E EUCLID ST, MCPHERSON KS 67460-3847 and at the US Department of Labor in Washington DC, or obtain a copy from the US Department of Labor upon payment of copying costs.
